All necessary markings for the platform and its container to be in English and French.

Inflation System

Gas medium: Carbon dioxide/Nitrogen mixture.

Operating Head: THANNER DK 99.

Condition of approval

1. The inflatable rescue platform is to be constructed in accordance with manufacturer's drawings listed above and no departure from these drawings shall be made without prior notification to Transport Canada Marine Safety.
2. Production line unit approval is conditional upon compliance with:
 - Life Saving Equipment Regulations
 - Transport Canada Standard for Life Rafts and Inflatable Rescue Platforms – TP7321.
3. This certificate may be suspended or cancelled if the manufacturer deviates from any of the conditions described herein without the prior consent of the Board of Steamship Inspection. The manufacturer is responsible that every platform built to this Certificate of Approval corresponds to the approved prototype.
